

167. ANNOUNCEMENTS FROM THE MAYOR

The Deputy Mayor informed members that Cllr Jackie Gregory was now out of hospital and recovering well at home.

168. ANNOUNCEMENTS FROM THE CLERK OF THE COUNCIL

The Clerk of the Council made the following announcements:

a. Knowsley Town Council Bank Account

Members were made aware that the due to assess of risk, the FCA states that the Chairman of the Town Council needs to be linked to the Town Council bank account in the future.

Members noted the change and agreed that any member wishing to hold the office of Mayor of the Town Council would have to be linked to the Town Council bank account.

b. Unauthorised Access - Sanctuary Woodlands

Members received a verbal update relating to the unauthorised access to Sanctuary Woodlands by contractors hire by the homeowner of "Suncot".

Members noted the update and the progress being made to secure the access to the site and making good the damage caused.

c. Public Footpath/Right of Way - Gellings Farm, Knowsley Village

The Clerk informed members that both herself and the Deputy Mayor had arranged a meeting with footpath officers to discuss the right of way issue relating to the footpath leading to Gellings Farm and that members would receive an update as soon as possible.

The Clerk of the Council was requested to ascertain a definitive footpath map for the whole of the township.

d. **CCTV - COMMUNITY PAVILION**

Following the incident of sound being present in the Committee Room, in the Community Pavilion, the Deputy Clerk met with the engineer from the CCTV company to try to find out how the sound had been turned on in the room. The engineer was unable to ascertain how long or who was responsible for the sound being switched on in the room.

Members were informed that all cameras had now been isolated from sound and that the problem should not be repeated.

Members requested that the incident be referred to a meeting of the Human Resources Committee for its consideration.

170. RISK ASSESSMENT 2023/2024.

Following consideration of the risk assessment for 2023/2024, as presented by the Clerk of the Council, it was **UNANIMOUSLY RESOLVED** to:

- a. approve the risk assessment undertaken during 2023/2024 to identify the risks involved in achieving the Town Council's objectives.
- b. approve the review undertaken during 2023/24 into the adequacy of control measures to manage those risks.

171. A REVIEW OF THE EFFECTIVENESS OF INTERNAL AUDIT (2022/23)

Members considered a written report submitted by the Clerk of the Council and it was **UNANIMOUSLY RESOLVED** that:

- a. The Town Council approved the review undertaken of the effectiveness of the internal audit arrangements (2022/23) in respect of the following five areas:
 - Scope of the internal audit
 - Independence of the internal auditor
 - Competence of the internal auditor
 - Relationship regarding elected members, Clerk of the Council and the independent auditor
 - Planning and reports regarding internal audit.
- b. Mr D Blanchflower be appointed as the internal auditor for the financial years 2023/2024, 2024/2005.
- c. The review of the effectiveness of internal audit arrangements to be undertaken during the financial year 2025/2026.

172. A REVIEW OF THE EFFECTIVENESS OF THE SYSTEMS OF INTERNAL FINANCIAL CONTROLS (2023/24)

The Accounts and Audit Regulations (2015) (Section 6) requires smaller authorities, each financial year, to undertake a review of the effectiveness of their systems of internal financial controls and to prepare an annual governance statement in accordance with proper practices in relation to the Town Council's accounts.

Following consideration of a written report submitted by the Clerk of the Council, it was **UNANIMOUSLY RESOLVED** that the Town Council approves the review undertaken of the effectiveness of its systems of internal financial controls for the year 2023/2024.
